The COVID-19 pandemic has caused people to rethink the core drivers of their lives. The foundations of wealth, job, financial security and health have been shaken. Am I putting my faith in biblical, lasting values? The present situation is an opportunity to reflect on our enduring objectives. What can we learn?

Simon is the Founder & Managing Director of **Pacific Equity Partners** (PEP). PEP is the largest local private equity firm in Australia and New Zealand. Funds managed by PEP have made more than 30 operating company investments, and more than 100 bolt-on acquisitions. PEP VI closed in June 2020 at the hard cap of A\$2.5 billion. PEP has also raised a Secure Assets Fund of A\$360 million to invest in infrastructure-like assets with contracted base cashflows where it can apply its formula of value addition to deliver mid-teen returns. The firm has approximately A\$3.5 billion in assets under management. It is the largest private equity fund manager in Australasia as measured by FUA. The background of the PEP principals in strategy and implementation combines with the industry knowledge and operational experience of portfolio management teams to deliver full potential at individual operating companies. PEP is frequently recognized by the industry as a leader and has received many awards including Firm of the Year, Best LBO Deal of the Year and Private Equity Firm of the Year, and has been included in the list of Top 20 Consistent Performers Globally by Pregin.

Prior to founding PEP, Simon was a Partner with Bain & Company and worked as a strategy consultant in the US, Singapore and Sydney. He started his working life as an engineer with The Royal Dutch/Shell Group in The Netherlands. Simon received a BSc (Eng) in Civil Engineering from the University of Bristol, and an MBA from the Wharton School where he was a Thouron Scholar.

Until relocating to England in 2013, Simon was the chairman of Gospel Patrons Society in Australia. GPS was established in 2000 to encourage business people to think strategically about supporting gospel ministry with their time and talents as well as financially. He founded the influential economic think tank, the Allegheny Institute, and has lectured extensively to university, business and civic groups.

He has been a member of three investment committees, among which is Benchmark Financial, Pittsburgh's largest financial services firm. Jerry is a regular commentator on Fox Business News and Fox News and was a Forbes columnist. He was formerly a CNBC Contributor, has guest-hosted "The Kudlow Report", and has written for CNBC, National Review Online, The Wall Street Journal as well as many other publications. 

Brad is the Founder of Indykko Ltd. and the Chariman & Co-Founder of **Pela**. He is a serial entrepreneur who started his first venture in his teens and has always supported himself through business. Brad was pursuing a career in health care when he was inspired to get into the kid's business by reading a story about a young entrepreneur who invented a toy and built a successful business. From that example Brad was compelled to develop his first toy company; "bootstrapping" it from a basement condo and growing it to become one of the largest Canadian toy companies in the early 2000s. Along the way this venture received several awards and accolades including the: CYBF growth award; four consecutive rankings among the Profit 100 companies (2001 - 2005); 2012 Profit 500 ranking and an Ernst and Young Entrepreneur of the Year nomination.

Brad was a founding partner of Tech 4 Kids in 2008 and focused on first building a best in class leadership team. The result of the group's efforts is that they have been able to grow profitable company revenues to +\$60M; operating out of three offices and trading into over 60 countries around the world.

In 2017 Tech 4 Kids merged with The Bridge Direct as part of an M & A strategy to rapidly scale a toy enterprise by acquiring other businesses with strong revenues and leveraging sourcing and consolidating overheads. The newly formed company was named Basic Fun and the first acquisitions included we'll know brands Uncle Milton and Knex, creating consolidated revenues of nearly \$150M.

In late 2017 Brad exited Basic Fun and after taking some time off founded Indykko Limited, a Hong Kong-based incubator that invests in CPG startups and provides infrastructure for product development and sourcing. The companies first investment is in Open Mind Development, a leader in developing sustainable products and the owner of the Pela brand.

Despite much-celebrated early success, Brad is no stranger to adversities in business. During the mid 2000s the company fell on financial difficulty and was forced into restructuring which ultimately ended up in bankrupting the company a few years later. It is said that mastery lives on the mountain top of mistakes and as such the crucible of failure creates valuable lessons that shape our future. Brad used these lessons from the business failure as a catalyst to create better business models.

How to lead in unique and challenging times? A big challenge for leaders is how to make economic adjustments, pivot, and to rethink existing practices. Is there a "new normal" or is it a matter of starting over again? Glenn Cooke started small and now leads a large organization. The company was started in 1985 by Glenn, his brother Michael and their father Gifford and now employs over 10,000 people globally in 10 countries, ships over one billion pounds of fresh, sustainable True North Seafood Company branded products a year to over 67 countries and generated \$2.35 billion CAD in sales last year.

The Cooke Inc. family of companies includes global aquaculture divisions including its wholly-owned subsidiary Cooke Aquaculture Inc. and Kelly Cove Salmon Ltd., as well as seafood and wild fishery divisions under Cooke Seafood USA, Inc., Icicle Seafoods, Inc., Wanchese Fish Company, Inc. and Omega Protein Corporation. Cooke Aquaculture Inc. is a vertically-integrated family company based in Blacks Harbour, New Brunswick, Canada, with salmon farming operations in Atlantic Canada, the United States, Chile and Scotland as well as seabass and seabream farming operations in Spain and shrimp farming in Honduras and Nicaragua.
